Chain of Events Leading to Civil War	
The Election of 1860	- There were four candidates in the election because proslavery and antislavery factions of the Democratic Party chose different candidates; some Southerners formed the Constitutional Union Party. - Northern Democratic candidate: <u>Stephen Douglas</u> - Southern Democratic candidate: <u>John Breckinridge</u> - Constitutional Union candidate: <u>John Bell</u> - Republican candidate: <u>Abraham Lincoln</u> - Although he did not receive a majority of the popular vote, Lincoln received enough <u>electoral</u> to win the election. - The election showed how <u>fragmented (divided)</u> the nation was.
Secession	- After South Carolina learned that Lincoln had won the election, it responded by <u>seceding from the Union</u>. - Southern leaders who opposed secession: <u>Tenn. senator Andrew Johnson</u> <u>Tex. Gov. Sam Houston</u> - First state to secede from the Union: <u>South Carolina</u> - Name of the new southern nation: <u>Confederate States of Am.</u> - President of the southern nation: <u>Jefferson Davis</u> - Lincoln's message to seceding states: <u>he assured the seceded states that he meant them no harm and that he would not interfere with slavery where it existed.</u> - Response of seceding states to Lincoln's message: <u>rejection</u> <u>they seized federal property in their borders</u>
Fort Sumter	- Lincoln's plan to deal with the siege of Fort Sumter: <u>send a supply ship with no guns so southerners wouldn't think he was attacking them</u> - South Carolina's response to Lincoln's plan: <u>They fired on the fort, capturing it and starting the Civil War</u>
