dominated by cereals and therefore likely to be deficient in essential vitamins minerals and proteins The AFSUN survey shows clearly that urban households obtain their food mainly through the market and therefore stable macro economic conditions are essential to their food security Since urban household food security is positively associated with levels of income promotion of decent employment is critical Among the urgent measures AFSUN recommends to address Lusaka s food insecurity are the promotion by government of decent employment including labour intensive public works programmes that would stimulate formal employment and supplementary feeding programmes in clinics and schools **Comprehensive**
