Pro Rata Debts

Pro-rata debts are debts incurred by a partnership or joint venture (JV) which are shared equally by all partners or JV partners. These debts arise when the partners or JV partners contribute to the partnership or JV capital and the partnership or JV incurs debts. The debts are shared equally by all partners or JV partners because they have all contributed to the partnership or JV capital and are therefore equally responsible for the debts incurred by the partnership or JV.

Example: A partnership of three partners, A, B, and C, has a total capital of ₹10,00,000. The partnership incurs a debt of ₹2,00,000. The debt is shared equally by all three partners, i.e., ₹66,667 each.
