Protecting the educational institutions is implanting the way of assisting the healthy generation who would contribute to the stable development. Indonesia advocates a comprehensive policy approach including prevention, treatment and rehabilitation, effective law enforcement and international cooperation.

Drug abuse in educational institutions is a major global concern, endangering the public health, safety and well-being of students, who are among the most vulnerable groups in society. Schools and universities, intended to be safe spaces for learning and growth, are increasingly being targeted by drug traffickers. The proliferation of cheaper and more accessible synthetic drugs, combined with increased academic pressure and social influences, is pushing more and more students towards drug addiction. The digital drug trade has further intensified the problem, with online platforms being used to trade and distribute drugs to young people, further complicating law enforcement efforts. According to the United Nations Office on Drugs and Crime (UNODC), more than 35 million people worldwide suffer from drug use disorders, and a large proportion of these people are young people, especially students. In Indonesia, this global crisis is taking on even more serious proportions. The National Narcotics Agency (BNN) reports that more than 3.5 million Indonesians have used drugs, a significant number of whom are high school and university students. Among students, factors such as peer pressure, academic stress, curiosity, and the increasing availability of drugs such as methamphetamine, ecstasy, and synthetic cannabinoids add to the problem. The problem is particularly acute in urban areas, where social inequalities and access to illegal substances are more pronounced.

Indonesia has adopted a zero-tolerance policy against drug trafficking, with severe penalties, including the death penalty for major offenders, as a measure to deter the illegal drug trade. Though this policy has been criticized, Indonesia claims that it gives priority to the collective rights of society, particularly the youth, over the actions of individuals who put public health and safety at risk. Drug trafficking and abuse do not only violate the rights of victims but also undermine the future of communities by targeting vulnerable groups like students. Balancing enforcement with human rights, Indonesia also focuses on rehabilitation and prevention. School-based campaigns, "Say No to Drugs" initiatives, and the designation of drug-free zones are some of the efforts made to build awareness and resilience within educational institutions. Rehabilitation centers, such as the Lido facility, offer psychological and educational support to reintegrate affected youth into society.
