PAYMENT OF SERVICE TAX

- In terms of section 68(1) of the Act, liability to pay service tax falls on the service provider.
- Overriding the aforesaid position, section 68(2) of the Act empowers the Central Government to notify such services on which such person, as may be prescribed, shall be liable to pay service tax.
- By virtue of this section, a person other than the service provider can be made liable to pay service tax and he shall be deemed as if he is the person liable for paying the service tax on such service and all other provisions of this Act shall apply accordingly.
- Finance Act, 2012 inserts a proviso to section 68(2) of the Act, wherein it is provided that the service provider and the service receiver can jointly be made liable to pay service tax on the same transaction.

Benefit of threshold limit of Rs.10 lakhs is not be available to Service Receiver and thus the service receiver has to pay service tax on all the specified input services received.
