Mrs. Doyle was transported by ambulance to Toronto General Hospital.

After her examination by the hospital's emergency doctor, Dr. Doe, Mrs. Doyle was diagnosed with a grade II Whiplash via physical examination and x-ray.

As a result of this diagnosis, Mrs. Doyle was referred by her physician to seek aid by way of alternative health care, as there was no fracture or disc dysfunctions present.

Mrs. Doyle decided to continue to receive care in my practice, and came in for an assessment appointment the second day after her injury.
