42.4B, 44/2011. In exercise of the powers conferred by sub-section (3) of section 73 of the Finance Act, 1994 (32 of 1994) read with section 115 of the said Act and in supersession of notification number 12/2002-Service Tax, dated the 17th March, 2002, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (2) with number 42.4B, 2011 (11), dated the 17th March, 2011, the Central Government, being satisfied that it is necessary in the public interest to do, hereby amends the following taxable services from the scope of the service tax leviable thereon under section 66B of the said Act, namely:-

1. Services provided to the United Nations or a specified international organisation;
- 2.13 Health care services by a clinical establishment, or medical health practitioner or practitioner;
- (2) Services provided by way of transportation of a patient to or from a hospital, where that patient is admitted to or from;
- 2.4, services provided by medical health service by way of preservation of dead cells or any other service in relation to such preservation;
- 2B, services provided by operators of the Common War Medical Welfare Establishment Facility to a clinical establishment by way of treatment or disposal of the medical waste or the patient's excreted wastes;
3. Services by a temporary clinic or infirmary to hospitals or clinics or homes;
4. Services by an entity registered under section 129A of the Income Tax Act, 1961 (23 of 1961) by way of charitable activities;
5. Services by a person by way of:-
 - (a) visiting or presence of a religious place, meant for general public, owned or managed by an entity registered as a charitable or religious trust under section 129A of the Income Tax Act, 1961 (23 of 1961) or as an exempted entity under section 129A of the Income Tax Act, 1961 (23 of 1961) or as a trust or an institution registered under sub-section (3) of clause (2C) of section 10 of the Income Tax Act, 1961 or an authority created under clause (2)(B)(a) of section 10 of the Income Tax Act, 1961 notified under Notification No.20/2001-Service Tax, or
 - (b) conduct of any religious ceremony;
 6. Services by a specified organisation in respect of a religious pilgrimage facilitated by the Ministry of External Affairs of the Government of India, under bilateral arrangements;
 6. Services provided by:-
 - (a) an official medical or
 - (b) any person other than a business entity; or
