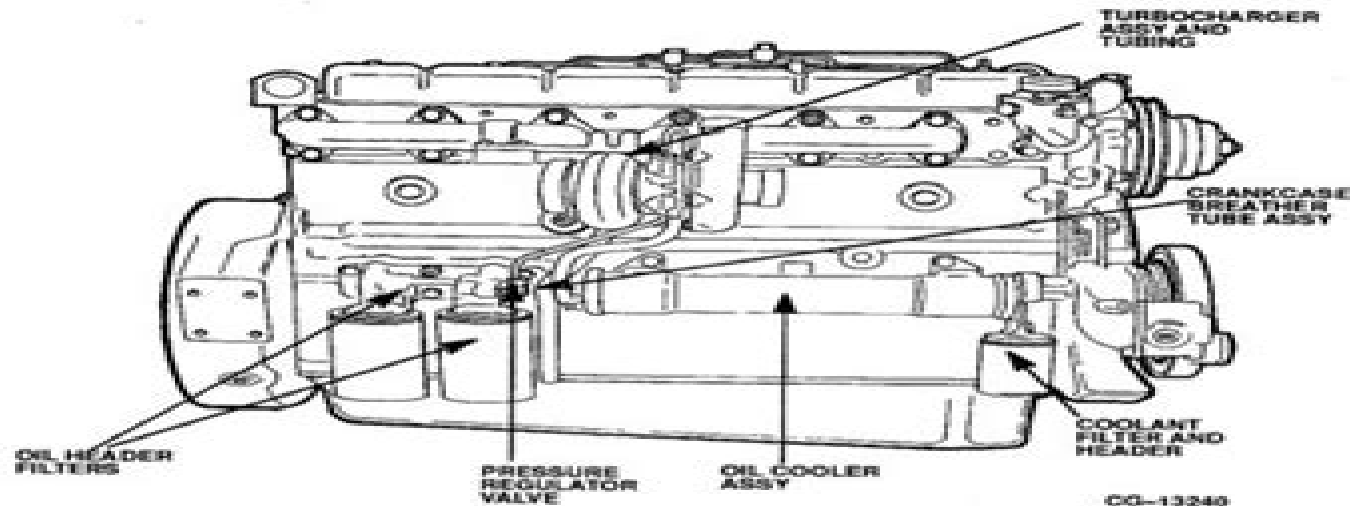


Figure 1.1. Component Removal Prior to Mounting the Engine on the Stand

1. Remove the items indicated in Figure 1.1 to allow installation of the engine on the mounting stand.

NOTE: WC engines require removal of the charge air cooler assembly and the corresponding pipes and engine mounting bracket.

NOTE: Remove 45 degree elbow located in oil galley behind oil cooler assembly in order to mount adapter plate.
