### **II. RATIONALE:**

In the early days of Philippine fishing industry, tuna was caught just a little over 100 meters from shore off Mindanao. Today the closest they can be found in volume is beyond 15km from the shoreline or within the commercial fishing waters. To reach this far, our fishermen will need a commercial scale fishing boat.

Longline fishing is usually used to catch tuna species. It will use one or more long heavy fishing lines with a series of hundreds or even thousands of baited hooks hanging from the main line by means of branch lines called "snood". Hand operated longlining can be operated from boats of any size. The number of hooks and lines handled depends on the size of vessel, the number of crew, and the level of mechanisation. Large purpose built longliners can be design for single species fisheries such as tuna, thus this project will provide commercial scale tuna fishing boat with complete accessories and longlines fishing gear.

### **III. OBJECTIVES:**

The general objectives of this project aims to develop and upgrade beneficiaries' knowledge and skills on tuna fishing using commercial scale fishing boat in order to increase income, provide sustainable livelihood and employment among fisherfolk and contribute to food security and poverty alleviation program.

### **IV. METHODOLOGY:**

The project will be focused on operation and maintenance of the commercial scale tuna fishing boat. The project will be exposing the beneficiaries on the theoretical and actual application of the technology of tuna fishing using commercial scale tuna fishing boat.

This book is about the ongoing transition of fisheries governance from top down command and control towards a more transparent and participatory form. It focuses on the emergence of research practices and advice frameworks that allow co-creation of common knowledge bases for management. Drawing from 8 years of research in GAP, a two-stage 7th framework EU project, the book offers a critical examination of how knowledge practices in fisheries governance are changing. The entry point for this research is a series of practical experiments in the uncharted terrain of collaborative research. To gain insight into the ongoing transition in European fisheries management, GAP initiated and carried out 13 Case Studies in different settings across Europe. In each case study, a team of fishers and marine scientists worked together to identify, plan, and implement research projects intended to make a difference. The cases vary. They take on different management issues and shape the collaborations in different ways. The extent to which they succeed in realizing their objectives also differs. They are all contributing important insights into the possibilities of co-creating knowledge for management purposes. The book delves into the individual experiences of each case study as well as the lessons they contribute as a whole. The examination concludes that while research partnerships are not always easy to establish, they are an important step towards better fisheries governance. Without a common knowledge base for fisheries governance co-created through collaborative research practices, sustainable fisheries will remain out of reach.

The workshop was attended by 45 participants from people's organizations, fisherfolk cooperatives, non-governmental organizations, national government agencies, and financing institutions. The discussions at the workshop showed that livelihood diversification and the improvement of income and employment opportunities in coastal fishing communities are crucial for their participation in the conservation and management of aquatic resources. Key elements of sustainable micro-enterprise development as identified by the workshop include capability building of fisherfolk organizations such as cooperatives and associations to implement livelihood projects, the preparation of feasibility studies and business plans, technical skills development, sound financial management practices, development of innovative and high quality products, access to new markets including urban and regional markets, and the full participation of fisherfolk in the identification of livelihood activities and micro-enterprises. The Pilot Project in Support of the Development of Micro-enterprises in Banate Bay, Iloilo and Southern Iloilo was implemented by

the University of the Philippines in the Visayas in cooperation with the Banate Bay Resource Management Council Inc and the Southern Iloilo Coastal Resource Management Council with support from FAO A number of microenterprises were introduced and supported in the municipalities of Banate Bay and Southern Iloilo including fish ball production shrimp paste production oyster and mussel culture salt production and iodization fish marketing and fish sauce production Training programmes were conducted for fisherfolk on product development and marketing of their products Good coordination with local government units active participation of all stakeholders and conduct of appropriate training programmes are considered essential for the sustainability of the micro enterprises The involvement of fisherfolk in livelihood activities and micro enterprises is strengthening their participation in the fisheries and aquatic resources management councils of Banate Bay and Southern Iloilo The experiences of the pilot project also suggest that in order to make various income generating livelihood initiatives sustainable and stand on their own feet many of these need to develop further into full fledged micro enterprises Considerable scope lies in farming of aquatic organisms such as seaweed shellfish and various fish species as well as in fisheries related value adding activities such as fish processing and marketing As far as the relationship between the conservation of aquatic resources and the generation of income is concerned the quality of the aquatic environment and the economic success of mariculture micro enterprises and activities are directly related This should create a strong motivation for fisherfolk entrepreneurs involved in such type of enterprises to be strong advocates and stewards of a healthy coastal ecology In the long term fisherfolk will benefit from the development of various micro enterprise initiatives It is clearly in their interest
