

Topic 6- Positive Accounting Theory

Why do we bother discussing theories when we are studying financial accounting?

Theory definition- what is a theory

A coherent group of propositions or principles forming a general framework or reference for a field of inquiry. In accounting, theories can be broken into positive and normative theories. Positive theories explain and predict, and normative theories prescribe what should happen.

Development of Accounting Theory

Positive Accounting Theory (PAT)

- PAT explains and predicts accounting practice but does not seek to prescribe particular actions.
- Focuses on relationships between various individuals involved in providing resources to an organisation. E.g. between owners and managers or, between managers and debt providers.
- PAT is concerned with explaining accounting practice and is designed to explain and predict which firms will and won't use a particular method. PAT does not make any recommendations as to what method a firm should use.
- PAT base on the concept of separation of ownership and control.

Agency Relationship

- A contract under which one or more principals engage another person (an agent) to perform some service on their behalf which involves delegating some decision-making authority to the agent.
- Relies on traditional economics literature. Assumptions of self interest and wealth maximisation. Self-interest is basic to survival (not selfish, considered to be rational and not contrary to concern for others or ethics).

The invisible hand

Assumptions of PAT

- All individual action is driven by self-interest. Is this realistic?
- Individuals will act in an opportunistic manner to increase their wealth.
- Loyalty and morality not incorporated within the theory.
- Organisations are a self-interested collection of individuals who agree to cooperate to the extent of their interest.

PAT predictions

- To improve efficiency, organisations will seek to put in place mechanisms to align the interests of managers of the firm (agents) with the interest of the owners (principals).
