7. Create a production schedule.
8. Edit for consistency.
9. Establish a review.

- **Other Documents.** This might include email formatting, forms, office signatures.

- **Building Layout and Access.** Maps of the building and office layout access to the office outside of business hours.
- **Job Descriptions.** Identify responsibility for jobs and tasks.
- **Supplies and equipment.** Location of supplies and equipment, and maintenance procedures.
