WHEREAS, the parties previously entered into an agreement, dated \_\_\_\_\_ (the "Agreement"), regarding the payment of child support by \_\_\_\_\_ to First Parent in the amount of \_\_\_\_\_, for the care and support of the minor child; and

WHEREAS, it is the desire and intention of the parties to adjust the monthly payments by the \_\_\_\_\_ previously fixed in the Agreement.

NOW THEREFORE, both parties freely and fully accept the provisions, terms and conditions hereof and in consideration of the promises and mutual covenants herein contained as well as for other good and valuable considerations not herein specifically set forth, the parties do hereby agree to the following:

1. **Child Support.** The parties agree that \_\_\_\_\_ shall pay to First Parent the sum of \_\_\_\_\_ as and for child support. The child support shall be paid directly to First Parent beginning \_\_\_\_\_ and shall be paid on the first day of every other week thereafter. The amount of child support has been determined in accordance with the applicable state child support guidelines, attached hereto as Exhibit A. The parties acknowledge that the child support arrangement shall not be legally binding until approved in a court order.

2. **Minor Child's Tuition Expenses.** The parties agree that \_\_\_\_\_ shall be responsible for all reasonable expenses related to the minor child's schooling, including tuition, books and supplies and transportation.

3. **Minor Child's Medical Insurance.** \_\_\_\_\_ shall be responsible for all premiums and expenses related to medical insurance for the minor child.

4. **Waiver of Payment Through Clerk.** Both parties waive participation in any applicable Central Depository Payment Program or the payment of child support through any clerk of court, direct deposit program or other third party entity (the "Central Depository"); and accordingly, payments need not be made through the Central Depository and shall be made directly to the party entitled thereto. In the event of the tardiness of payments or other difficulty experienced by the receiving party, either party may subsequently apply to the Central Depository to activate participation and have child support payments directed through the Central Depository in the event that it becomes necessary to secure or obtain payments made hereunder.
