Mindy is a 10 year old Caucasian female (she is an only child). Her mom (single parent) brought her to therapy because she says Mindy has been having problems since the divorce of her parents (six months ago). Mindy is having the following symptoms and she is presenting with these symptoms in both school and at home. She is reportedly sad most days of the week. She reports feelings of hopelessness, helplessness, and often cries on and off during the week. She reports difficulty with attention and concentration, her grades are declining in math and science because she is not motivated to do her homework. She often isolates herself in her room and she refuses to help out with the chores. She reportedly plays on the internet for hours and texts her friends all night long. She reports she gets about 5 hours of sleep per night and she denied going for days without sleep. In the session she reports that she sometimes thinks about suicide but she clearly denied a plan. She makes statements like the following: "my life sucks, no one really cares about me, I'll never amount to anything."

This thesis includes the first randomized controlled study on CBTbased email therapy and the first internet based behavioral activation program with ACT components for adult depression.
