Constitutional Powers

Expressed powers- Powers specifically given to Congress in Article 1 Section 8.

Delegated powers- Government function granted and assigned to a specific branch of the federal government under the U.S. Constitution.

Implied powers- Powers not directly stated in the Constitution but rather interpreted as belonging to the national government.

Concurrent powers- Powers shared by the national, state, and or local government.

Reserved powers-State government powers

Resolution-

Jurisdiction- the authority of a court to hear certain types of cases; the authority or geographic area of authority to enforce laws or make legal judgements.

Elastic clause-allows the government to make laws that are considered necessary and proper that are not directly given in the Constitution.

General welfare clause- powers granted to the federal government to create legislation that promotes the general public, thus upholding its duties listed in the Preamble.

Interstate commerce-activity involving people or businesses in more than one state
