The price of securities in the secondary market is determined by supply and demand 3 Explain the concept of IPO Initial Public Offering Answer An IPO is the process through which a private company offers shares to the public for the first time to raise capital The company hires underwriters investment banks to determine the pricing and number of shares to issue Once the shares are issued they begin trading on the stock exchange marking the transition of the company from private to public ownership 4 What is the role of investment banks in capital markets Answer Investment banks facilitate the issuance of securities in the capital markets They underwrite securities assist with pricing and help market new issues to potential investors. They also provide advisory services such as mergers and acquisitions M A advice and help in structuring complex financial products 5 What is a bond and how does it work Answer A bond is a debt security issued by a corporation or government entity promising to pay the bondholder a specified interest rate coupon over a fixed period and repay the principal at maturity Bonds are used by issuers to raise capital for various purposes The risk and return depend on the bond s credit rating the interest rate environment and the issuer's financial stability 6 What are the key types of financial instruments traded in capital markets Answer The main financial instruments in capital markets include Equity Stocks Shares of ownership in a company which entitle the shareholder to dividends and capital gains Debt Bonds Instruments where investors lend money to an issuer in exchange for regular interest payments and repayment of principal at maturity Derivatives Financial contracts whose value derives from the performance of an underlying asset e g options futures swaps Mutual Funds ETFs Pooled investment vehicles that invest in a diversified portfolio of securities 7 What is the relationship between risk and return Answer The risk return trade off is the principle that potential return rises with an increase in risk In capital markets investors seek to balance the desire for the lowest possible risk with the highest possible return Higher risk investments typically offer higher returns to compensate investors for taking on that risk 8 What is a stock exchange and how does it function Answer A stock exchange is a
